MIPS is comprised of four components: Quality, Promoting Interoperability (PI - formerly known as Advancing Care Information), Clinical Practice Improvement Activities (CPIA), and Cost. Each of these four components are unique and complex. Seamlessly integrating all four components can be challenging, but failure to do so will put your fee-for-service payments at risk.
